Data storage and deletion

Your data is stored securely in cloud infrastructure located in the United States. We retain your data only as long as necessary for the purposes outlined above or as required by law. When no longer needed, we securely delete your data using industry-standard methods.

Data security

We implement robust security measures, including encryption in transit and at rest, role-based access controls, and regular security audits, to protect your personal data from unauthorized access or disclosure.
